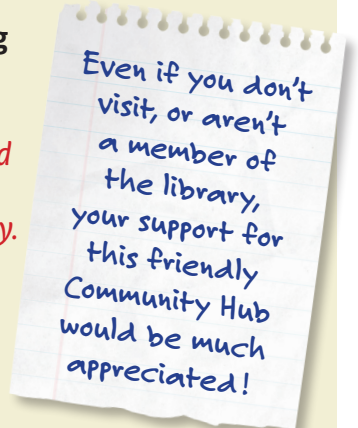
We also have an extremely dynamic Family Activities Group running regular Story Times, Seasonal Trails through Watlington, and many other events.
